The handle on the dishwasher is loose. The attic fan in the guest bedroom works but the on/off switch is in need of repair. The back screen door needs repair, as do a couple of the screen windows (in all cases, the screen itself needs replacing). There are cracks in the original stone fencing (dating to 1932).
